Membership Application Procedures:

1. The Board of Management meets on the third Thursday of every month to review all applications for membership. The General Manager may grant early access to the Club, however, final approval for all memberships rests with the Board of Management.
2. Applicants' names are posted in the Club for 14 days for review by Club members.
3. Applications for Full Time Student status must be supported by valid student identification.
4. Outport Membership applications must include evidence of residence and business location to support inclusion in this membership category.

** By signing the application form, you are acknowledging your continuing membership in the Royal Nova Scotia Yacht Squadron. You will remain a member until such time as written notice of resignation is received by the Club Secretary. Members who have not resigned 45 days after the commencement of the fiscal year of the Squadron will be liable for the payment of the dues for such fiscal year.*

Personal Information Protection and Electronic Documents Act (PIPEDA)
